HIGHWAY MOTORS WRITTEN WARRANTY

Highway Motors hereby provides a Limited Written Warranty on all repairs you and Highway Motors have agreed upon stated in Repair Order # \_\_\_\_\_. This warranty is valid for as long as you own the vehicle stated herein, and is for the person whom this Limited Warranty is granted, and whose name appears herein on the original Repair Order # \_\_\_\_\_. This Warranty is not transferable. This Warranty shall only apply if the defects occurred under normal driving conditions, and not where any vehicle has been subjected to accidents, negligence, abuse or misuse. THIS WRITTEN WARRANTY SHALL BE NULL AND VOID IF THE REPAIR IS ALTERED, ADJUSTED, OR TAMPERED WITH BY ANY PERSON NOT AUTHORIZED BY WARRANTY GRANTOR. This is a fragmented, four part Written Warranty, and specific additional stipulations pertaining to each fragmented part are stated hereafter.

1. METAL WORK: Highway Motors provides a Lifetime Limited Warranty, from effective date stated herein, against defective workmanship to include welding and the application of materials utilized in making collision repairs against cracking, flaking, pitting, or deterioration, excluding rust repairs. Highway Motors will, at its sole option, repair and repaint any metal work warranted hereby.
2. PAINTING, STRIPES, AND DECALS: Highway Motors provides an "As Long As You Own Your Vehicle" Limited Written Warranty, from effective date stated herein, on painting related priming and paint work against solvent blistering, peeling, hazing, and excessive loss of pigmentation. Paint warranty is only valid if over original factory finishes that are free of defect. An "As Long As You Own Your Vehicle" Limited Written Warranty is provided, from effective date stated herein, on the application and adhesion of decorative stripes and decals, excluding defects caused by extreme environmental conditions to which the vehicle may be exposed. Highway Motors will, at its sole option, re-prime, re-paint, re-stripe, or re-decal the specific sections of the vehicle warranted hereby.
3. MECHANICAL REPAIRS: Highway Motors provides a twelve (12) month 12,000 mile Limited Written Warranty, from effective date stated herein, on all mechanical repairs pertaining directly to original collision damage excluding suspension, air-conditioning, or other electrical assemblies or components. Highway Motors will, at its sole option, re-repair any mechanical assembly or component, unless caused by or damage resulting from unreasonable use, maintenance, or care of the vehicle.
4. PARTS: Highway Motors guarantees that parts or materials used are of the first quality. Those parts and materials are subject to the guarantee of that supplier. We will assist you in handling any claim under the suppliers guarantee. We guarantee that used parts or after-market parts other than original equipment manufactured parts were not used without authorization from you as noted in the repair order. Highway Motors provides an "As Long As You Own Your Vehicle" Limited Written Warranty, from effective date stated herein, unless manufacturer's warranty is less, on all new parts installed by or at Highway Motors, excluding suspension, air conditioning, or other electrical assemblies or component. Highway Motors will repair or replace any defective part warranted hereby, at its sole option, when claim is made while the present owner stated herein owns the vehicle, unless caused by or damaged resulting from unreasonable use, maintenance, or care of the vehicle
5. SPECIFICALLY EXCLUDED: Incidental costs, such as towing fees, car rental charges, travel expenses, or assemblies or components which are not specifically covered by this Limited Written Warranty, nor are consequential damages such as damage to other assemblies and components resulting from a defective part or installation of such part installed or repaired during the repair included in this Written Warranty.
6. CUSTOMER OBLIGATIONS: In order to obtain the benefits of this warranty, the owner of the vehicle must do the following: A. Present the owner's copy of the warranty document to the warrantor before requesting warranted parts or repairs B. Have any warranted repair, adjustment, or inspection made only at the premises of the warrantor during normal business hours.
